We appreciate the PUC's time and effort at Tuesday's hearing.

We are still requesting PECO's utility records for 97 Deepdale Rd. as those records will allow us to evaluate PECO's pending settlement proposal, and, more importantly, will allow us to gauge what risks we are incurring at present by having 250 feet of live utility wire crossing our property while a pole of questionable quality and risky installation is supposedly holding it in place close to my home. This pole, located on my property, is within ten feet of my home and is tied into PECO's own utility grid on the street. This is part of the utility service that was relocated from the original utility pathway running down the opposite side of the driveway to 103 Deepdale Rd. We understand that PECO's own policies require that relocations and installations be documented so it is definite that this information exists.

Again, we are asking the PUC to compel PECO to disclose their records as my family's personal safety should trump their unwillingness to disclose their records.
