Dear Secretary Chiavetta:

On March 8, 2011 we filed a Certificate of Satisfaction in the above case, based on our understanding after discussion with the customer that the case was resolved. Mr. Cook has subsequently contacted us and indicated that he has reconsidered and would rather not have the case marked closed now, but instead wishes to wait for certain outside facility work to be completed. Verizon is planning to place new poles and replace cable that provides his telephone service.

Accordingly, at the request of the above customer, we would like to ask that this case not be closed at this time and that instead it be placed in mediation until the outside facility work is completed. We will report our progress to the mediator and we are hopeful that once the work is completed we can file another certificate of satisfaction and close the case.

Your consideration in this matter would be greatly appreciated. If you are in agreement, we will provide an update on this case to the mediator by Friday, April 15.

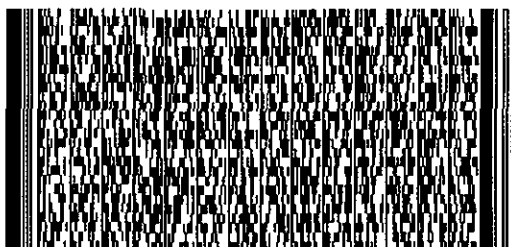
