





On November 16, 2010, Resource Energy Systems, LLC filed an Application for a license to supply electricity or electric generation services in Maryland under COMAR 20.51. Additional information was filed on December 27, 2010. The Company proposes to provide electricity supplier services in Maryland for commercial and industrial customers as described in the application.

After considering this matter at the January 12, 2011 Administrative Meeting, the Commission granted Resource Energy Systems, LLC a license to supply electricity or electric generation services in Maryland in accordance with its Application (License Reference Number IR-2115). Dear Mr. Plutzer:

This is to confirm that the New Hampshire Public Utilities Commission (Commission) has received Resource Energy Systems, LLC's notice of intent to provide electric aggregation service in the State of New Hampshire, pursuant to New Hampshire Administrative Rules Puc 2003.05. Staff has reviewed the application provided and believes that it meets the requirements of Puc 2003.05. Based on Staff's recommendation and the Commission's review, the Commission approves Resource Energy Systems, LLC's application to provide electric aggregation service in New Hampshire.

Please note the following provision of Puc 2003.05 (f): "[E]ach approved aggregator shall re-notify the commission after the initial 2 year period, or after the 5 year renewal period as applicable, by filing with the commission an application for renewal at least 60 days prior to the expiration of the currently effective registration." Resource Energy Systems, LLC's original notice anniversary date is November 4, 2010 and therefore it is required to refile an up-to-date written notice on or before **September 14, 2012** if it continues to offer and provide electric aggregation service. In addition, Resource Energy Systems, LLC is subject to the provisions of Puc 2004.03, telephone solicitation of customers, and Puc 2004.08, customer protections provided by aggregators.






