

Dear Ms. Kellie,


UGI Gas, Inc. (UGI) has reviewed the financial information of Planet Energy Corporation. ("Planet Energy"). Based on this review and the requirement that Planet Energy must post security as specified in the UGI Natural Gas Supplier Coordination Tariff before it serves customers on the UGI distribution system, UGI has determined that Planet Energy has demonstrated adequate creditworthiness to satisfy any costs UGI may incur in the event it must operate as a supplier of last resort due to a default on the part of Planet Energy.

This determination may change in the event there is a material deterioration in that condition, if Planet Energy's obligations to UGI exceed the amount of the financial security provided, if the financial security is withdrawn or is deemed to be null and void or inadequate due to the material financial deterioration of any guarantor, or if Planet Energy fails to abide by the terms and conditions of UGI Tariff and the UGI Natural Gas Supplier Coordination Tariff.

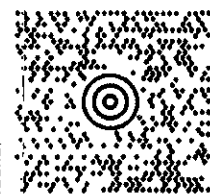
