SECOND CERTIFICATE OF SATISFACTION OF COMPLAINT


1. Complainant is Emerson V. Phillips.

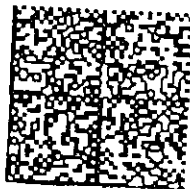
