To Whom It May Concern:

On October 12, 2010, the Bureau of Transportation and Safety instituted a complaint against Marco Tralongo, t/a Quality Limousine Service, respondent, alleging that respondent, between December 1 and December 31 of 2006, 2007, 2008, and 2009, did not provide this Commission with a current list of all of its vehicles utilized under its limousine authority, a violation of 52 Pa. Code §29.333(d).

Respondent was duly notified that, if an answer was not filed within twenty (20) days of receipt of the complaint, the penalty would be imposed.

The complaint and notice were published in the Pennsylvania bulletin on December 4, 2010. More than twenty (20) days later, no response has been received from respondent.

Therefore, the allegations in the complaint are admitted and the complaint is sustained.

Respondent, within twenty (20) days from the date of service of this letter, shall pay a fine of two hundred fifty dollars (\$250.00) by certified check or money order payable to the Commonwealth of Pennsylvania and mailed to the Pennsylvania Public Utility Commission, at P.O. Box 3265, Harrisburg, PA 17105-3265, as provided in the Public Utility Code, 66 Pa. §§3301 and 3315. Respondent shall cease and desist from further violations of the Public Utility Code, 66 Pa. C.S. §§101, et seq., and the Regulations of this Commission, 52 Pa. Code §§1.1, et seq.
