RE: Notices of Payment Default and Imminent Disconnection of Local Service – Pennsylvania

Dear Secretary Chiavetta:

By two letters, each dated June 21, 2010, Verizon Pennsylvania Inc. (Verizon) notified Comcast Phone of Pennsylvania, LLC and Comcast Business Communications, LLC respectively, that each of the two Comcast entities was in default of bill payment obligations to Verizon under applicable interconnection agreements and tariffs. The letters stated that absent timely payment, Verizon would suspend processing of Comcast service orders and/or would terminate all services provided under an applicable interconnection agreement, on or after September 8, 2010.

By letters dated September 16, 2010, October 25, 2010, December 2, 2010, January 20, 2011, February 15, 2011 and March 18, 2011 Verizon informed the Commission that by mutual agreement the parties had extended the date for any such termination notices first to October 25, 2010, then to December 10, 2010, then to January 21, 2011, then to February 25, 2011, then to March 25, 2011, and then to April 22, 2011. By this letter Verizon informs the Commission that by mutual agreement the parties have extended the date for any such termination notices to May 20, 2011.

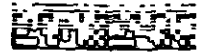
