Dear Secretary Chiavetta:

The case listed above is being scheduled for hearing as discussions were unsuccessful between myself and counsel for the Pennsylvania American Water Company (PAWC) concerning my previously submitted list of property rights violations filed with the Commission against the PAWC.

Since my phone conference earlier this week with Attorney Brian Knipe representing the PAWC, I have discovered a disturbing new issue to this case. A section of new waterline buried late last summer is outside the right-of-way and on my property at the corner of Mercer and Duffy Roads in Center Township, Butler County. It is approximately the final 90 feet where Duffy Road "T's" with Mercer Road. The pipe was buried far off the 33 foot right-of-way intruding into the corner of our large front yard. I'm sorry this was not discovered earlier and put up for discussion, but the end result to go to hearing would be the same.

I am basing my measurement of this intrusion on the straw covered area where digging was done and new grass is just sprouting. Most certainly, the water company has a more sophisticated way of locating their lines and they are welcome to come and verify the correctness of my observation. **They will need to call me in advance before coming onto my property. Because of the gross misconduct of the PAWC contractor last summer I have given the PAWC, through Attorney Knipe a no trespassing notice.**

Following their confirmation that the line is out of the right-of-way, we expect it to be dug up and moved. If they do not move promptly on this newly discovered issue, I will expect it to be discussed and acted on at the PUC hearing being scheduled.

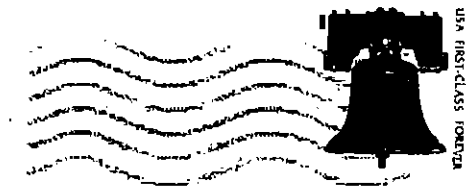
