Then on June 8 I went in for a total right knee replacement so I couldn't drive and had to find some one to drive ~~me~~ me back and forth to my therapy sessions. I'd come out and then stay with her. In July she went back in because she wasn't eating or drinking enough and ~~got~~ <sup>Just a note...</sup> dehydrated this time again they sent her to a nursing →

home for rehab but she didn't do so well  
and since she didn't they made me take  
her out. So I took her home. I ended up  
back in the hospital in July with terrible  
back spasms. After another week in there I  
was let go again to. I don't know if they know  
for sure but suspect them either. They thought  
kidney stones, then bladder infection. Then after  
then we were both home and doing fairly  
well or so we thought. Sept 1 a lady turned  
over in front of me on Rt. 23. I was going  
23 E and she was going 23 W and wanted to  
~~go E on 30~~ so she had to make a left turn  
which she did right in front of me and I  
hit her broadside and hit both my knees  
up against the dash. Had to go get X-ray again of  
the one I just had surgery on. But thank the  
nothing inside was harmed or dislodged, it was  
just badly bruised. Then on Sept 31, Mother ended  
up in the Hospice Center and drew her final  
breath at 2:30 A.M. on Sept 31.

I know I had gotten that letter and the one to  
send in ~~so~~ earlier also and had I sent that  
in I would not have to pay this one because I  
didn't last year but that is my penalty for not  
getting it done and sent in, so I'll pay it the  
time but I laid it aside and forgot about

it until the other day when I was  
thinking over things that I'll need to

popped up and the letter came to mind  
and I look for it and couldn't find it  
then today Oct 11, I was looking for my  
husband's checkbook which I have mis-  
placed also and I came across this  
letter also, but not the checkbook.  
I hope with the gear that I have  
had that you'll find it in your heart  
to cut me a break from any more  
charges for this being late. I really am  
sorry but I've been in a fog and  
under a lot of stress this year.

Also I wish you would change  
my last name on your records  
I think that I sent you a copy of my

can let me know what I have to  
do.


