CERTIFICATE OF SATISFACTION OF COMPLAINT

1. Complainant is Timothy E. Klotz.
2. Respondent is PPL Electric Utilities Corporation (hereafter referred to as "PPL").
3. This Certificate of Satisfaction of Complaint is submitted pursuant to 52 Pa. Code § 5.24(b).
4. PPL hereby certifies that the parties to the above-referenced formal Complaint, now pending before the Pennsylvania Public Utility Commission (hereafter "Commission"), have mutually and voluntarily agreed upon the following terms as full satisfaction of all outstanding legal and factual disputes in this proceeding, and Complainant has acknowledged satisfaction to PPL:
 - (a) Complainant, Timothy E. Klotz, and Respondent, PPL, agree that PPL rebilled Complainant in the amount of \$4,042.85 for unbilled usage on his electric account. PPL will apply a credit in the amount of \$606 to Complainant's account, which will reduce the current balance to \$6,974.84.
 - (b) Complainant has requested a change in his bill due date to the middle of each month. PPL has agreed and will change the due date on his bill to approximately the middle of each month.

(c) Complainant agrees to pay \$217.75 on his account balance by May 15, 2011. Thereafter, beginning with the bill due June 2011, Complainant will pay his current bill plus \$117 per month towards arrearages until all arrearages are paid in full. So long as Complainant makes complete timely payments, PPL will not assess any interest, penalties, or fines on the overdue amount.

(d) PPL will refer Complainant to OnTrack. It is specifically understood by all parties that PPL will make the referral, cannot opine as to whether or not Mr. Klotz will be eligible for OnTrack.


(e) Complainant withdraws his Complaint.

5. Respondent, PPL hereby notifies Complainant of the filing of this Certificate of Satisfaction, and that if Complainant objects or disagrees with the terms of the Certificate of Satisfaction, Complainant must notify the Commission in writing of his objection and/or disagreement within ten (10) days of the date this Certificate of Satisfaction was signed and served, or the terms of the Certificate of Satisfaction will become final and binding.




