Mark E. McShane, Senior Vice President, Supply

Mark McShane joined Green Mountain Energy Company in spring 2011, as Senior Vice President, Supply. Prior to joining Green Mountain, Mark was with NRG Energy and Reliant Energy for 20 years, serving in multiple capacities and responsibility levels in the areas of power planning, dispatch, portfolio development, risk management and supply execution. From 2009 through February 2011, Mark served as Director, Retail Supply. In this role, Mark was responsible for long-term portfolio development and operational hedging for the retail supply portfolio in the ERCOT market. From 2006 to 2009, Mark served as Vice President, ERCOT Energy Supply and was responsible for commercial performance including scheduling operations, supply execution, load forecasting, portfolio development and origination. From 2001 to 2006, Mark served as Director, Energy Supply and was responsible for day-ahead and real-time execution of the supply portfolio, including scheduling, cash trading and portfolio optimization. From 1996 to 2001, Mark served as Manager, Long-Term Planning and was responsible for ensuring that adequate resources were available for long-term and short-term planning horizon to meet retail demand and support joint dispatch operations. From 1990 to 1996, Mark served as an Energy Management System Engineer, directing a project team in the design, development and implementation of software applications to support transmission and generation dispatch.

Mark McShane received a Bachelor of Science in Electrical Engineering from the University of Texas in Austin.
