ARTICLES OF ORGANIZATION
OF METZLER FOREST PRODUCTS, LLC

The undersigned, for the purpose of forming a limited liability company under the Pennsylvania Partnership and Limited Liability Code (15 Pa.C.S. § 101 *et seq.*) [the "Act"] does hereby make, acknowledge and file the following Articles of Organization.

ARTICLE I

NAME

The name and style of the limited liability company shall be:

METZLER FOREST PRODUCTS, LLC (the "Company")

ARTICLE II

DURATION

The Company shall commence its existence on the date that these Articles of organization are filed with the Pennsylvania Department of State and shall terminate twenty (20) years after its commencement, unless the Company is earlier dissolved as provided in these Articles of Organization, the Operating Agreement, or under the Act.

ARTICLE III

PURPOSE AND POWERS

The general purpose for which the Company is organized is to transact any lawful business for which a limited liability company may be organized under the laws of the

Commonwealth of Pennsylvania, and the Company shall have all of the powers granted to a limited liability company under the laws of the Commonwealth of Pennsylvania.

ARTICLE IV

REGISTERED OFFICE AND AGENT

The name and street address of the registered agent and the registered office of the Company in the Commonwealth of Pennsylvania is:

ARTICLE V

CAPITAL CONTRIBUTIONS

The members of the company shall contribute to the capital of the Company in the amounts agreed by the members.

ARTICLE VI

MEMBERS, ADMISSION OF NEW MEMBERS

No additional members shall be admitted to the Company except with the written consent of all of the members of the Company and upon such terms and conditions as shall be determined by the members. A member may transfer his interest in the Company solely as set forth in the Operating Agreement of the Company, but the transferee shall have no right to

participate in the management of the business and affairs of the Company or become a member unless the transferee is approved to be a member.

ARTICLE VII

TERMINATION OF EXISTENCE

The Company shall be dissolved upon the death, insanity, resignation, expulsion, bankruptcy or dissolution of a member or upon the occurrence of any other event which terminates the continued membership of a member in the Company, unless the business of the Company is continued by the consent of the greater of a member Majority Vote or a Majority in Interest (as these terms are defined in the Operating Agreement).

ARTICLE VIII

MANAGEMENT

The Company shall be managed by its Members. Each member shall have a number of votes (including fractions) equal to such member's Units in the Company with the total number of votes of all members totaling One Hundred (100).
