


RESPONSES OF MARK MAZZA TO PRELIMINARY OBJECTIONS/
MOTION TO DISMISS OF PECO ENERGY COMPANY

Peco Energy Company filed an answer and preliminary objections on or about May 4, 2011. The preliminary objections identify a docket number of C-2010-2171324. Said preliminary objections do not apply to the above action and should be stricken, dismissed or overruled. Any motion to dismiss the PUC complaint should be denied. Peco Energy Company then filed Preliminary objections on or about May 12, 2011. It is averred the preliminary objections are untimely, and it is further averred Peco waived filing preliminary objections since the May 4, 2011 filing included an answer to the PUC complaint. It is contended Peco Energy Company is barred from submitting preliminary objections since they have filed an answer and the rules of civil procedure do not allow preliminary objections since an answer to the complaint has already been filed. It is averred the motion to dismiss should be denied or dismissed as untimely. Mark Mazza hereby incorporates this paragraph in responses to preliminary objections filed on May 12, 2011 and preliminary objections filed on May 4, 2011 should the PUC decide those preliminary objections although with the wrong docket number.

!-14. Denied. The prior complaints and the instant complaints speak for themselves.

The current complaint asserts new actions and /or behavior by Peco Energy Company regarding sufficiency ,legality and timeliness of shutoff or termination notices. Further, complaints allege new facts by Peco Energy Company' of recent activity pertaining to improper or insufficient termination of services efforts and improper attempts to terminate services at complaintant's property. The complaint avers inaction by Peco to address resolution of the matter. Further Peco attempted shutoff even after complaintant had the complaints delivered to the PUC. Despite contacting Peco about the filings Peco still attempted to terminate services without due process and hearings on the issue. The remaining allegations are denied as conclusions of law. Strict proof is demanded.

WHEREFORE, complaintant requests the preliminary objections be dismissed as untimely or overruled and that the motion to dismiss be denied.


