

PETITION FOR LEAVE TO WITHDRAW INTERVENTION OF QWEST
COMMUNICATIONS COMPANY, LLC

TO THE HONORABLE CYNTHIA WILLIAMS FORDHAM:

Pursuant to Section 5.94(a) of the Pennsylvania Public Utility Commission's ("Commission") regulations, 52 Pa. Code §5.94(a), Qwest Communications Company, LLC ("QCC"), by and through its counsel, John F. Povilaitis, and Buchanan Ingersoll & Rooney PC, submits this Petition for Leave to Withdraw its intervention in this proceeding.

I. Background

By Order entered May 11, 2010, the Commission lifted its stay of the access charge investigation at this docket and assigned the investigation to the Office of Administrative Law Judge ("OALJ") for development of an appropriate evidentiary record and issuance of a Recommended Decision. The OALJ thereupon contacted the parties who had been active in this proceeding to determine if they were going to actively participate in the reactivation of this docket. QCC, through its counsel, advised OALJ that it would continue to participate in this proceeding.

By Prehearing Order dated December 3, 2010, the Presiding Officer scheduled a further telephonic prehearing conference for Wednesday, December 8, 2010 at 2:00 p.m. On December 7, 2010, QCC submitted its Prehearing Memorandum in this matter. With respect to its description of its issues in this case, QCC stated in its prehearing memorandum that "Qwest will be actively monitoring the proceeding to protect its interests, but does not have any issues to identify and bring forward at this time." Also, to date QCC has not identified any witness on its behalf and has not served any testimony in the reactivated docket.

II. Discussion

Consistent with its position at the prehearing conference, QCC has not identified any issues it wishes to pursue in this docket. Therefore to conserve its resources, it requests leave to withdraw from this proceeding. This withdrawal will not adversely affect any other party in the proceeding, nor will it affect the outcome of contested issues in this case. Therefore QCC requests that it be granted leave to withdraw its intervention. Upon the granting of this Petition, counsel for QCC should be removed from the parties' service lists.

III. Conclusion

Therefore, QCC respectfully requests that its Petition for Leave to Withdraw its intervention in this proceeding be granted, and that the service list of this proceeding be amended by removal of the undersigned and QCC co-counsel, Douglas Hsiao, Esq.


