

- (b) Complainant agrees to withdraw his Complaint with prejudice.





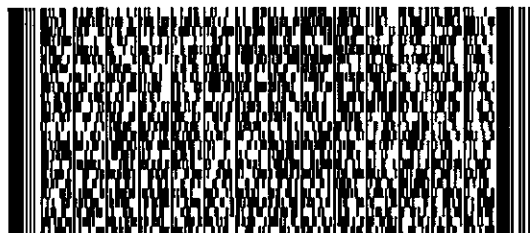
