The purpose of this letter is to advise you that, pursuant to your Second Prehearing Order on Remand dated May 16, 2011, representatives of Donsco, Inc. ("Donsco") and PPL Electric Utilities Corporation ("PPL Electric") conducted in-person settlement discussions on Monday, June 13, 2011. Prior to the settlement discussions, PPL Electric had provided to Donsco's representatives data relative to rates charged to Donsco and the cost of serving Donsco pursuant to formal and informal discovery requests. At the settlement discussion, Donsco agreed to provide, and since has provided, work papers supporting a proposal that it presented during the settlement discussions.

We cannot report that any settlement has been achieved at this time, but the parties are continuing to exchange information and to engage in further settlement discussions.


