1. In your response to Item 4.c. and Item 8.a. of the EGS license application, you indicate that ArcelorMittal USA LLC proposes to procure wholesale power for use by ArcelorMittal USA LLC, its subsidiaries and affiliates. Based on this information, would it be accurate to state that as a licensed EGS, ArcelorMittal USA LLC intends to purchase electricity in the wholesale market, and then resell it to its subsidiaries and affiliates as a retail supplier of power?

Yes, the paragraph above accurately reflects the operational intentions of ArcelorMittal USA LLC as a licensed EGS.

2. In your response to Item 8.a. of the EGS license application, you state that ArcelorMittal USA LLC currently procures retail market electricity for all subsidiaries and United States based affiliates. Does ArcelorMittal USA LLC currently provide this electricity procurement service to subsidiaries and/or affiliates in Pennsylvania? If so, explain how this procurement service differs from the service you intend to provide as a licensed EGS.

Yes, ArcelorMittal USA LLC currently procures retail market electricity for subsidiaries and affiliates located in Pennsylvania. As a licensed EGS, ArcelorMittal USA LLC would be able to procure wholesale electricity rather than retail electricity at favorable rates for subsidiaries and affiliates located in Pennsylvania.

3. Is ArcelorMittal USA LLC currently licensed or otherwise authorized to supply electricity to retail customers in other states? If so, please indicate which states you are currently authorized to operate in as a supplier of retail power.

ArcelorMittal USA LLC currently procures retail electricity in the manner described in question 2 for subsidiaries and affiliates located in Ohio and Illinois. ArcelorMittal USA LLC has applied for license in Ohio and Illinois to procure wholesale power in a similar manner as a Pennsylvania EGS and expects a positive outcome in the near future.



In your response to Item 8.a. of the EGS license application, you indicate that ArcelorMittal USA LLC is applying for an EGS license to procure wholesale power solely for itself, its subsidiaries and affiliates. Does ArcelorMittal USA LLC have any future plans to supply power to customers other than its subsidiaries or affiliates?

ArcelorMittal USA LLC does not have any plans in any time frame to supply power to customers other than subsidiaries and affiliates. Any future change to this plan would be presented to the commission for further guidance.

5. Please provide professional resumes for any key employees of ArcelorMittal USA LLC who will be directly involved in the company's electricity procurement and sales operations.
