

RE: UGI Financial Security Requirements


Dear Mr. Palmese:

UGI Utilities, Inc. ("UGI") has reviewed the financial information of Palmco Energy PA. LLC ("Palmco"). Based on this review and the requirement that Palmco must post security as specified in the UGI Penn Natural Gas ("PNG") and UGI Utilities Gas ("UGI") Supplier Coordination Tariffs before it serves customers on the PNG and UGI distribution systems, UGI has determined that Palmco has demonstrated adequate creditworthiness to satisfy any costs PNG and UGI may incur in the event it they operate as a supplier of last resort due to a default on the part of Palmco.

This determination may change in the event there is a material deterioration in that condition, if Palmco's obligations to PNG and UGI exceed the amount of the financial security provided, if the financial security is withdrawn or is deemed to be null and void or inadequate due to the material financial deterioration of any guarantor, or if Palmco fails to abide by the terms and conditions of the PNG and UGI Gas Tariffs and the PNG and UGI Natural Gas Supplier Coordination Tariffs.

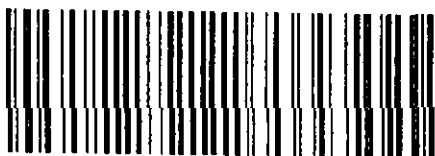

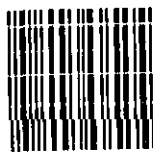
