The company has been in compliance with the Pennsylvania Public Utility Commission, and the Federal Motor Carrier Safety Administration.

4. We currently occupy 6,000 sf of Office and Warehouse. 3,000 is dedicated to Office and 3,000 sf is for warehouse and maintenance. Parking is available for 20 moving vans and 25 employee autos. We have a state of the art computer system. Additionally, we communicate with our drivers via cell phones.

We maintain record keeping in accordance with the rules of the Pennsylvania Public Utility Commission, and FMCSA. We will receive our customer's request for service via the internet and telephone.

5. We currently employ over 40 Movers and 20 Drivers. If awarded additional operating authority we will hire 10 Movers and Drivers. Initially, we will start with that number, and increase employment as required.

6. We intend to hire 5 Drivers, initially.

All Driver applicants must have the following:

Valid Driver's License
Submit to a Criminal Background Check
Submit to a Driving History Check
Be Drug Free

Pass a Road Check with a qualified instructor

Have an up to date DOT Commercial Drivers Physical Card.

All employees a subject to a criminal background check. A Human Resources individual is assigned to this task.

Our Driver training program consists for the following:
Classroom orientation 2- 2hours sessions
Viewing Safe Driving Videos 4 hours

Road Test with qualified instructor. Physical if required.

Every 3 months we do Driver History inquiries for all Drivers.

Every 2 years we do a Criminal Background on all Drivers. Both the Driver History and Criminal Background check are administered by our Human Resources Department.

TWO MEN AND A TRUCK is a "Drug Free Work Place" Our Employee Handbook describes a zero tolerance for drug use. All employees acknowledge and sign a receipt that they understand and will comply with our Drug Free Work Place policy. After any accident a drug test is mandatory. Additionally, we can have an employee take a drug test at any time for any reason.

- 7. See attached list of vehicles we currently operate. We assume if awarded additional operating authority, we will acquire 4 additional 26' Moving Vans.
- 8. We currently have a vehicle safety program which conforms to 67 Pa. Code Chapter 175 and 49CFR parts 393 and 396 as adopted by the PUC at 52 Pa. Code, Chapter 37 as applicable to HHG applicants.
- 9. We currently have in place adequate insurance coverage as required by the PUC and FMCSA and have paid the premiums in a timely manner.
- 10. Our Customer Service Representatives inform customers as to the procedure to file complaints with the PUC. As of this date no valid complaints have been filed with the PUC.
