

PUBLIC STATEMENT OF THE
OFFICE OF CONSUMER ADVOCATE
PURSUANT TO 71 P.S. SECTION 309-4(e)

Act 161 of the Pennsylvania General Assembly, 71 P.S. § 309-2, as enacted July 9, 1976, authorizes the Consumer Advocate to represent the interests of consumers before the Pennsylvania Public Utility Commission (PUC or Commission). In accordance with Act 161, and for the following reasons, the Consumer Advocate determined to file an Intervention and participate in proceedings before the Commission involving the proposed rate increase requested by PPL Electric Utilities Corporation (PPL).

On May 20, 2011, PPL filed its Generation Supply Charge-1 for the application period June 1, 2011 through August 31, 2011. The OCA has intervened in the proceeding to help ensure that any proposed changes to the Generation Supply Charge that may result from the Commission's investigation are just, reasonable, and otherwise consistent with Pennsylvania law.


