

**JOINT MOTION TO SUSPEND PROCEDURAL SCHEDULE**

---

Pursuant to Section 5.103(a) of the Pennsylvania Public Utility Commission's ("Commission") regulations, 52 Pa. Code § 5.103(a), Core Communications, Inc. ("Core"), and Choice One Communications of Pennsylvania, Inc. d/b/a One Communications and CTC Communications Corp. d/b/a One Communications (collectively, "One") submit this Joint Motion to Suspend the Procedural Schedule above-captioned proceedings. In support hereof, Core and One (collectively, "Joint Movants") state as follows:

1. On May 12, 2011, counsel for the Joint Movants appeared before Administrative Law Judge ("ALJ") Wayne L. Weismandel for a Prehearing Conference in the above-captioned proceedings.
2. During the Prehearing Conference the parties agreed to a procedural schedule for the exchange of prepared testimony, for the presentation of witnesses at evidentiary hearings and for

the submission of written briefs. The procedural schedule was memorialized in the Scheduling and Briefing Order issued by ALJ Weismandel on May 12, 2011.

3. On May 24, 2011, the Commission issued a Judge Change Notice reassigning the above-captioned proceedings to ALJ Susan D. Colwell.

4. Pursuant to the adopted procedural schedule, Core served its written Direct Testimony on June 8, 2011.

5. The Joint Movants have conducted informal settlement discussions that have resulted in an agreement in principle that would resolve all issues in these proceedings.


6. The Joint Movants request to suspend the procedural schedule to enable further discussions to finalize and document the agreement in principle.

7. The Joint Movants respectfully submit that suspension of the schedule to allow the parties to concentrate on finalizing settlement terms and conditions is in the public interest, and represents the most efficient use of the parties' and the Commission's resources regarding this matter.

8. If the Joint Movants cannot finalize the settlement, each reserves the right to subsequently request for the suspension to be lifted and for a new schedule to be established with adjusted deadlines that reflect the time expended in attempting to finalize the settlement.




