The purpose of this letter is to report on the status of the above-referenced matter. Pursuant to the Interim Order issued June 17, 2011, the Complainant Richard Shull ("Mr. Shull") and Respondent PPL Electric Utilities Corporation ("PPL Electric") held a conference to discuss and address the concerns and issues raised in Mr. Shull's Formal Complaint. The conference was held at 11:00 a.m. on July 12, 2011 at Mr. Shull's residence. Participating at the conference on behalf of Complainant were Mr. and Mrs. Shull. Participating at the conference on behalf of PPL Electric were James Rouland and Christopher T. Wright, counsel for PPL Electric.

The Parties were able to achieve a full resolution of this matter as a result of the above-described conference. The Parties currently are in the process of formalizing their agreement. The Parties have agreed that once the agreement has been executed, PPL Electric shall file a Certificate of Satisfaction requesting that the Commission mark the case closed pursuant to Section 5.24(b) of Title 52 of the Pennsylvania Code, 52 Pa. Code § 5.24(b).


