Dear Secretary Chiavetta:

Pursuant to Administrative Law Judge ("ALJ") Melillo's July 13, 2011, Order, enclosed for filing with the Pennsylvania Public Utility Commission are two (2) copies of the invoices issued by Core Communications, Inc. ("Core") to XO Communications Services ("XO") purporting to address traffic exchanged by the parties from June 2004 through May 2011, when the evidentiary hearing in the above-referenced matter was held. During that period, Core issued invoices to XO for Carrier Identification Codes ("CIC") 5119 and 5607. Consistent with the ALJ's directives, each invoice is separately labeled beginning with "XO Exhibit No. 11."
