Dear Secretary Chiavetta:

The purpose of this letter is to request that the Pennsylvania Public Utility Commission ("Commission") amend the Electric Generation Supplier license of Consumer Energy Solutions, Inc. ("CES") to include service, as a broker and marketer, to residential customers throughout the Commonwealth of Pennsylvania.<sup>2</sup>

Pursuant to your letter dated March 25, 2011, addressed to Electric Generation Suppliers and Electric Distribution Companies, we understand we are not required to publish notice of this amendment request in newspapers of general circulation, as required for original applications. We have not included a disclosure statement. As was the case with CES's original Application, all dealings with customers, regardless of size, will be in the capacity of a broker/marketer. CES will not be taking title to the electricity, nor will it be establishing rates or billing customers for electricity. As a broker/marketer, CES will provide to customers disclosure statements from the licensed entities it represents. If a disclosure statement is nonetheless required, one will be provided. All other information contained in CES's original Application remains unchanged.

CES agrees that it will comply with all applicable Chapter 56 residential service regulations.

<sup>2</sup> CES's original Application, which was approved by the Commission by Order entered January 29, 2010, authorized EGS service as a broker and marketer to commercial, industrial and governmental customers throughout the Commonwealth.


