

CERTIFICATE OF SATISFACTION OF COMPLAINT


1. Complainant is Kathleen Ryan.

PPL hereby certifies that the parties to the above-referenced *formal* Complaint, now pending before the Pennsylvania Public Utility Commission (hereafter "Commission"), have mutually and voluntarily agreed upon the following terms as full satisfaction of all outstanding legal and factual disputes in this proceeding, and Complainant has acknowledged satisfaction to PPL:
 - (a) Complainant, Kathleen Ryan, and Respondent, PPL, agree that Complainant will pay \$74 by August 22, 2011. Starting September 2011, Complainant will pay her current bill plus \$15 per month towards arrearages, until all arrearages are paid in full. 
