

CERTIFICATE OF SATISFACTION OF COMPLAINT


1. Complainant is Michele O'Connor.

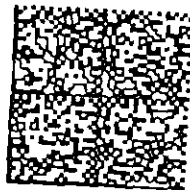
