

Cobb & Associates, Inc. with the Pennsylvania Department of State.

2. **Item 7.a. – Bonding:** Since the Applicant only selected Broker/Marketer in item 4.b., the Applicant appears to have selected the incorrect option (second choice) in item 7.a. The third choice appears to be the appropriate option in item 7.a. Please correct, if appropriate and provide the information requested to support a reduced bonding level of \$10,000.
