

PPL hereby certifies that the parties to the above-referenced formal Complaint, now pending before the Pennsylvania Public Utility Commission (hereafter "Commission"), have mutually and voluntarily agreed upon the following terms as full satisfaction of all outstanding legal and factual disputes in this proceeding, and Complainant has acknowledged satisfaction to PPL:

(a) Complainant, Tahamy Badre, and Respondent, PPL, agree that Complainant will pay her budget bill of \$175 by November 2, 2011, the next bill date. Thereafter, Complainant will continue to pay her budget bill plus \$20 per month towards arrearages, until all arrearages are paid in full. Complainant has been referred to the OnTrack Program. Complainant has also been referred to LIPEAP for November 1, 2011.


