PUBLIC STATEMENT OF THE
OFFICE OF CONSUMER ADVOCATE
PURSUANT TO 71 P.S. SECTION 309-4(e)

Act 161 of the Pennsylvania General Assembly, 71 P.S. Section 309-2, as enacted July 9, 1976, authorizes the Consumer Advocate to represent the interests of consumers before the Pennsylvania Public Utility Commission (Commission). In accordance with Act 161, and for the following reasons, the Consumer Advocate determined to file an Intervention and participate in proceedings before the Commission involving Kathleen Moran-Roberto's complaint concerning PNG's failure to extend gas mains to her home.

On June 9, 2011, Ms. Moran-Roberto filed a formal complaint with the Commission protesting UGI Penn Natural Gas's (PNG) proposed phase-out of the Gas Beyond the Mains (GBM) program. In her complaint, Ms. Moran-Roberto requested that she continue to receive gas at natural gas prices or, alternatively, that PNG extend gas mains to her home as promised in the 1970's. On July 6, 2011, the ALJ granted in part PNG's motion to consolidate Ms. Moran-Roberto's complaint with its 1307 (f) proceedings. However, the ALJ severed Ms. Moran-Roberto's complaint with respects to the main extension issue, which is the subject of this proceeding. Through its participation in this proceeding, the OCA seeks to ensure that the interests of Ms. Moran-Roberto and other similarly situated customers are duly considered. In addition, the OCA will work to ensure that Ms. Moran-Roberto's request for a main extension is handled in accordance with Pennsylvania law.
