

PUBLIC STATEMENT OF THE
OFFICE OF CONSUMER ADVOCATE
PURSUANT TO 71 P.S. SECTION 309-4(e)

Act 161 of the Pennsylvania General Assembly, 71 P.S. Section 309-2, as enacted July 9, 1976, authorizes the Consumer Advocate to represent the interests of consumers before the Pennsylvania Public Utility Commission (Commission). In accordance with Act 161, and for the following reasons, the Consumer Advocate determined to file an Intervention and participate in proceedings before the Commission involving Dolores Alar's complaint concerning PNG's failure to extend gas mains to his home.

On September 28, 2011 Ms. Alar filed a formal complaint with the Commission protesting UGI Penn Natural Gas's (PNG or Company) proposed phase-out of the Gas Beyond the Mains (GBM) program. In her complaint, Ms. Alar alleges that in 1967, in consultation with PNG's predecessor, she installed a gas heating system with the understanding that she would receive propane gas at natural gas prices until the Company installed gas lines to her home. Accordingly, Ms. Alar now requests that PNG continue to provide propane gas at natural gas rates until PNG extends natural gas mains to her property. Through its participation in this proceeding, the OCA seeks to ensure that the interests of Ms. Alar and other similarly situated customers are duly considered. In addition, the OCA will work to ensure that Ms. Alar's complaint is evaluated in accordance with Pennsylvania law.
