PUBLIC STATEMENT OF THE
OFFICE OF CONSUMER ADVOCATE
PURSUANT TO 71 P.S. SECTION 309-4(e)

Act 161 of the Pennsylvania General Assembly, 71 P.S. Section 309-2, as enacted July 9, 1976, authorizes the Consumer Advocate to represent the interests of consumers before the Pennsylvania Public Utility Commission (Commission). In accordance with Act 161, and for the following reasons, the Consumer Advocate determined to file an Intervention and participate in proceedings before the Commission involving John Calafut's complaint concerning PNG's failure to extend gas mains to his home.

On July 17, 2011, Mr. Calafut filed a formal complaint with the Commission protesting UGI Penn Natural Gas's (PNG) proposed phase-out of the Gas Beyond the Mains (GBM) program. In his complaint, Mr. Calafut requested that PNG install natural gas lines to his home or, alternatively, continue to provide propane gas at natural gas prices. Through its participation in this proceeding, the OCA seeks to ensure that the interests of Mr. Calafut and other similarly situated customers are duly considered. In addition, the OCA will work to ensure that Mr. Calafut's request is evaluated in accordance with Pennsylvania law.
