LEHIGH UNIVERSITY AND REQUEST TO CANCEL HEARING**


Pursuant to the provisions of Section 5.94(a) of the Pennsylvania Public Utility Commission's ("PUC" or "Commission") Regulations, 52 Pa. Code § 5.94(a), Lehigh University hereby petitions for leave to withdraw its Complaint against PPL Utilities Corporation ("PPL" or "Company") at the above-captioned docket. In addition, Lehigh University requests to cancel the Initial Hearing that is scheduled for October 31, 2011, in this matter.

1. On December 30, 2010, Lehigh University filed a Complaint against PPL regarding the notice procedures for changes in default service rates.
2. On January 10, 2011, PPL filed an Answer to Lehigh University's Complaint.
3. On August 26, 2011, the Commission issued a Hearing Notice for this matter scheduling an Initial Hearing on October 31, 2011.
4. Between the filing of the Complaint and today, Lehigh University determined that it no longer desires to pursue the Complaint. This decision was communicated to counsel on October 11, 2011.
5. As a result, Lehigh University requests to withdraw the Complaint (with prejudice) and to cancel the October 31, 2011, Initial Hearing.

**WHEREFORE**, for the foregoing reasons, Lehigh University respectfully requests that it be granted leave to withdraw the Complaint that was filed on December 30, 2011.


