1. In the transmittal letter dated August 9, 2011, and in item 4(b) of the application form, it is indicated that the award of a Certificate of Public Convenience is anticipated from the Commission. This filing is being processed as an application for a license as an electric generation supplier. Please indicate whether there us a misunderstanding of intent.

**Response**: The reference to a Certificate of Public Convenience was a scrivener's error. MC Squared intends to operate as an EGS licensee and not as a jurisdictional public utility.

 In item 4(b) it is indicated that the applicant proposes to operate as a generator of electricity. Provide a description of the manner in which MC Squared would provide generation services.

**Response:** It is anticipated that generation service will be procured from generation sources located within the PJM RTO including but not limited to generation owned by MC Squared's s parent who currently possesses approximately 3,800 megawatts of generation capacity in PJM. MC Squared itself has no generation capacity but will provide electricity to Pennsylvania customers through purchases from various generators and/or the PJM RTO.

3. The applicant's financial statements detail the company's poor performance results for the 2010 fiscal year. Indicate what steps have been taken to make the company profitable.

**Response:** MC Squared was acquired by DPL, Inc. on February 28, 2011. As set forth in response to item 7(b), MC Squared is relying upon the financial fitness of its parent.




