

**CERTIFICATE OF SATISFACTION OF COMPLAINT**


1. Complainant is Doon Holdings, Inc.

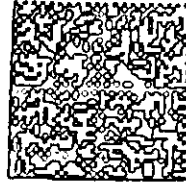
