

CERTIFICATE OF SATISFACTION OF COMPLAINT


1. Complainant is Kevin Shiffka.

 - (a) Complainant, Kevin Shiffka, and Respondent, PPL, agree that Complainant will pay \$181 by October 28, 2011. Thereafter, Complainant will pay his current bill plus 4100 per month towards arrearages, until all arrearages are paid in full.


