CERTIFICATION OF SATISFACTION

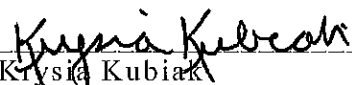

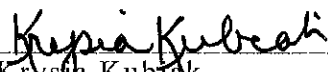
