

PPL hereby certifies that the parties to the above-referenced formal Complaint, now pending before the Pennsylvania Public Utility Commission (hereafter "Commission"), have mutually and voluntarily agreed upon the following terms as full satisfaction of all outstanding legal and factual disputes in this proceeding, and Complainant has acknowledged satisfaction to PPL:

(a) Complainant, Kenneth Wiest, and Respondent, PPL, agree that PPL will apply a \$1,000 credit to Complainant's account. It is further agreed that Complainant will pay his current monthly bill plus \$30 per month towards arrearages until all arrearages are paid in full. So long as timely monthly payments are made, PPL will not apply any late payment, penalty or interest charges.

(b) Complainant agrees to withdraw his Complaint.
