PURSUANT TO 71 P.S. SECTION 309-4(e)

Act 161 of the Pennsylvania General Assembly, 71 P.S. § 309-2, as enacted July 9, 1976, authorizes the Consumer Advocate to represent the interests of consumers before the Pennsylvania Public Utility Commission (Commission). In accordance with Act 161, and for the following reasons, the Consumer Advocate determined to file a Notice of Intervention and participate in proceedings before the Commission in the matter of Petition and Complaint To Stay Modification of PPL Electric Utilities Corporation Universal Service and Energy Conservation Plan for 2011 Through 2013 and To Stay Implementation of Appendix A to Tariff – Electric Pa. P.U.C. No. 201 Concerning Implementation of a CAP-Plus, at Docket No. M-2010-2179796 (Petition). The Petition was filed by the Pennsylvania Utility Law Project (PULP) on behalf of Lorrie Koons on November 22, 2011.

On June 2, 2010, PPL Electric Utilities Corporation (PPL) filed with the Commission for approval its Universal Service and Energy Conservation Plan for 2011-2013 at Docket No. M-2010-2179796. On February 18, 2011, PPL filed with the Commission for approval a Joint Petition for Settlement of All Issues. The Commission approved the Joint Petition for Settlement on May 5, 2011. In the current Petition, PULP seeks to prevent PPL from implementing its CAP-Plus plan.

By intervening in this Petition, the Consumer Advocate seeks to ensure that all relevant facts are developed on the record for the Commission's consideration. Further, the OCA seeks to protect and preserve the interests of PPL's customers contained in the Joint Petition for Settlement and Commission Orders.
