PPL hereby certifies that the parties to the above-referenced formal Complaint, now pending before the Pennsylvania Public Utility Commission (hereafter "Commission"), have mutually and voluntarily agreed upon the following terms as full satisfaction of all outstanding legal and factual disputes in this proceeding, and Complainant has acknowledged satisfaction to PPL:

(a) Complainant, Thaddeus D'Ambrosia, and Respondent, PPL, agree that PPL will apply a credit in the amount of \$400 to Complainant's account, number 59033-33376. This credit will be applied to Complainant's outstanding arrearage. In addition, PPL will maintain Complainant's payment arrangement of current bill plus \$20 per month towards arrearages, until all arrearages are paid in full.

(b) On or before December 9, 2011, PPL will provide a reminder to Customer Representatives who respond to Formal Complaints concerning the processing procedures.

(c) Complainant withdraws his Complaint.

5. 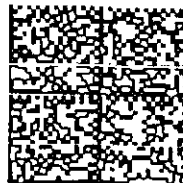
