



1. Complainant is Gregory Zettlemyer.
2. Respondent is PPL Electric Utilities Corporation (hereafter referred to as "PPL").

PPL hereby certifies that the parties to the above-referenced formal Complaint, now pending before the Pennsylvania Public Utility Commission (hereafter "Commission"), have mutually and voluntarily agreed upon the following terms as full satisfaction of all outstanding legal and factual disputes in this proceeding, and Complainant has acknowledged satisfaction to PPL:

(a) Complainant, Gregory Zettlemyer, and Respondent, PPL, agree that Complainant will pay \$252 by December 22, 2011. Thereafter, beginning with the bill due January 2012, Complainant will pay his current bill plus \$49 per month towards arrearages, until all arrearages are paid in full. In addition, PPL has made a referral on Complainant's behalf to the OnTrack Program.


(b) Complainant withdraws his Complaint.


