

CERTIFICATE OF SATISFACTION OF COMPLAINT


1. Complainant is Donna Wedge.

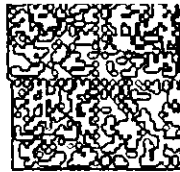
