COMPLAINANT'S RESPONNSE TO NEW MATTER OF AQUA PENNSYLVANIA, INC.

Aqua has already filed a Preliminary Objection to Complaint's case and the Complainant has provided a response. Aqua's Preliminary Objection was based on false statements, legal mumbo jumbo and attempts to muddy the water. Aqua's New Matter raises the same false statements, legal mumbo jumbo, and attempts to muddy the water in order to request dismissal of the Complainant's case. Aqua is attempting to take "two (2) bites of the apple" - seeking two separate rulings on the same issues. Aqua should be reprimanded for such an attempt and wasting the Commission's time and limited resources.

The following item numbers corresponds to item numbers of New Matter of Aqua Pennsylvania, Inc. (Aqua):

8. True in part and denied in part. It is completely unfair unreasonable and unjust when the cost of the customer charge is several times in magnitude the cost of water consumption for a very small number of customers who are senior citizens and live on Social Security such as the Complainant.
9. It is completely unrelated to the present case. AN EXAPLE OF LEGAL MUMBO JUMBO AND AN ATTEMPT TO MUDDY THE WATER.
10. DENIED. It is denied and **IT IS COMPLETELY FALSE** that "The present Complaint raises the very same claim concerning the Respondent's customer charge ..."

11. DENIED. It is denied and **IT IS COMPLETELY FALSE** that there has been "...a prior proceeding...".
12. DENIED. It is denied and **IT IS COMPLETELY AND UTTERLY FALSE** "The Complainant's attempt to re-litigate **the identical issue ...**".
13. DENIED. **IT IS COMPLETELY AND UTTERLY FALSE** that " ...attempting to re-litigate those issues in the 2010 Formal Complaint "
14. DENIED. **IT IS COMPLETELY FALSE** that "...was previously litigated in a prior proceeding ...".
15. DENIED. **IT IS COMPLETELY AND UTTERLY FALSE** to state that it is "...the same allegations" and to state that it is "...identical Complaint...".
16. DENIED. **IT IS COMPLETELY AND UTTERLY FALSE** to state that it is "...identical complaint". On the contrary this is a completely a new case and it does have anything to do with any other.

WHEREFORE the Complainant respectfully requests that this Honorable Court deny Aqua's request that the Complaint filed by Dale Sattar be dismissed. Aqua is trying to take advantage of my pro-se status by making untrue statement and citing unrelated cases.

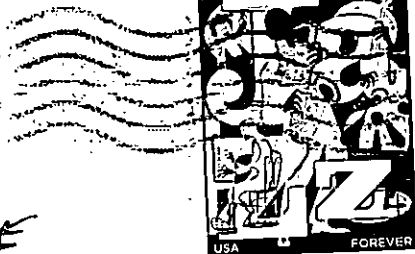
