

1. Complainant is Michael McCann.
2. Respondent is PPL Electric Utilities Corporation (hereafter referred to as "PPL").
3. This Certificate of Satisfaction of Complaint is submitted pursuant to 52 Pa. Code § 5.24(b).

4. PPL hereby certifies that the parties to the above-referenced formal Complaint, now pending before the Pennsylvania Public Utility Commission (hereafter "Commission"), have mutually and voluntarily agreed upon the following terms as full satisfaction of all outstanding legal and factual disputes in this proceeding, and Complainant has acknowledged satisfaction to PPL:

(a) Complainant, Michael McCann, and Respondent, PPL, agree that PPL will apply a credit to Complainant's account in the amount of \$282.97, reducing the amount of disputed debt from accounts 98271-55009 and 41494-47007 from \$2,829.72 to \$2,546.80. Complainant and Respondent further agree that Complainant will pay his regular monthly bill plus \$42.45 per month towards arrearages, beginning Complainant's February 2012 bill, until all arrearages are paid in full.

(b) Complainant agrees to withdraw his Complaint.

5. Respondent, PPL hereby notifies Complainant of the filing of this Certificate of Satisfaction, and that if Complainant objects or disagrees with the terms of the Certificate of Satisfaction, Complainant must notify the Commission in writing of their objection and/or disagreement within ten (10) days of the date this Certificate of Satisfaction was signed and served, or the terms of the Certificate of Satisfaction will become final and binding.




