To Whom It May Concern:

On behalf of Modern Motor Coach, Inc. d/b/a Modern Piano Moving, we respectfully submit this <u>Petition for Waiver of 52 Pa. Code. 31.121</u>.

Under 52 Pa. Code 31.121, the charge for moves that are less than 40 miles are based on an hourly rate. If the move is over 40 miles, the charge is based on weight and mileage.

Modern Motor Coach, Inc. d/b/a Modern Piano Moving's authority is "to transport, as a common carrier, by motor vehicle, household goods in use, limited to pianos and organs, between points in Pennsylvania."

As explained previously, Modern Piano Moving is the largest dedicated piano mover in the country. It provides the unique service of only moving pianos and organs. Likewise, the process of moving pianos and organs is unique. Unlike regular household goods such as books, pots and pans, piano and organs are not simply thrown in a box and placed on a truck.

The process of moving pianos and organs can be very complicated. Each move is unique based upon the size and type of piano or organ and the location of the pick-up or delivery site. Due to the size and shape of pianos and organs, negotiating steps and turns can be extremely difficult. In addition, on many occasions, special equipment is used, such as ATV's and cranes, to facilitate the safe move of the piano and organ without damaging the object or the customer's property.

As a result, Modern Piano Moving has a very detailed formula for pricing each move. This formula takes into account the size and type of piano or organ, the number of steps and turns that must be negotiated, the mileage between the two points, and the costs of extra equipment or labor. A copy of the proposed tariff is enclosed for your review.

This formula is used for all interstate moves and for all intrastate moves in every other state. If Modern Piano Moving was required to use a flat hourly rate or strictly use a mileage and weight rate for Pennsylvania intrastate moves, the other factors that must be considered or equipment used would not be considered. As such, Modern Piano Moving would be forced to set an exorbitant hourly or weight rate to cover the complicated moves. This would not be fair to the customers who have less complicated moves. It would also not allow for discounts for moves that have open pick-up and delivery dates.

In addition, Modern Piano Moving cannot predict how long each will take. Each move is unique and the amount of time required for each move cannot be properly estimated until the movers arrive at each location and assess the situation. While Modern Piano Moving works with its customers in advance to anticipate any difficulties, i.e., turns, tight staircases, etc., the length of time for an actual pick up or delivery can vary with each move.

Modern Piano Moving prides itself on moving pianos in a safe and professional manner, taking great care of the cherished instruments of their customers and their surrounding property. Its employees are specially trained to move pianos and organs very carefully. The pricing formula normally used by Modern Piano Moving takes into consideration all of the necessary elements to ensure a safe and damage-free move for their customers.

As such, Modern Motor Coach, d/b/a Modern Piano Moving, respectfully requests a waiver of 52 Pa. Code 31.121.

Timing Costs

If regular move, no multiplier is used. Regular moves have a 30 day pick-up and then a 30 day delivery window.
