

(a) Complainant, Roseann Murphy, and Respondent, PPL, agree that on or about June 14, 2010, an unpaid balance of \$1,492.95 was transferred from account number 10360-06051 to account number 17840-06150. The final balance on account number 17840-06150 is \$1,459.93. PPL agrees to apply a customer credit on account number 17840-06150 in the amount of \$1,342.01, leaving a balance of \$117.92, which shall be paid within thirty (30) days.


(b) Complainant agrees to withdraw her Complaint.
