The purpose of this letter is to report on the status of the above-referenced matter. Pursuant to the Interim Order issued December 9, 2011, counsel for Complainant Jay Larry Moyer and Respondent PPL Electric Utilities Corporation ("PPL Electric") held a telephonic conference to discuss and address the concerns and issues raised in Mr. Moyer's Formal Complaint. The conference was held at 2:00 p.m. on January 6, 2012. Participating at the conference on behalf of Complainant was John K. Baillie, Senior Attorney for Citizens for Pennsylvania's Future. Participating at the conference on behalf of PPL Electric were Keith R. Erney, Communications Specialist at PPL Electric, Aloysius P. Cannon Jr., Financial Business Planning Specialist at PPL Electric, and Christopher T. Wright, counsel for PPL Electric.

The Parties were unable to achieve a full resolution of this matter at the above-described conference. However, PPL Electric has submitted an initial proposal for Complainant's consideration and the Parties have agreed to continue to further discuss this matter in an attempt to fully and amicably resolve the issues raised by Complainant. The Parties agree that it is unnecessary at this time to proceed to formal litigation or mediation. PPL Electric represents that it has spoken with counsel for Complainant and certifies that all Parties concur with the foregoing.


