

On September 26, 2011, the Formal Complaint of Sandra Hughes and Kenneth Songer was filed at PUC Docket No. C-2011-2266021.

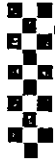
Robert Wyant and Judith McCrea, on behalf of Corsica Gas Company, filed a Response to the Formal Complaint on October 21, 2011.
