

CERTIFICATE OF SATISFACTION OF COMPLAINT


1. Complainant is Nilsa Vasquez.

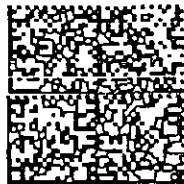
