

PPL hereby certifies that the parties to the above-referenced formal Complaint, now pending before the Pennsylvania Public Utility Commission (hereafter "Commission"), have mutually and voluntarily agreed upon the following terms as full satisfaction of all outstanding legal and factual disputes in this proceeding, and Complainant has acknowledged satisfaction to PPL:
 - (a) Complainant, Jose Rosario Montanez, and Respondent, PPL, agree Complainant will pay \$257 by February 17, 2012. Thereafter, beginning with the bill due March, Complainant will pay his current monthly bill plus \$120 per month towards arrearages, until all arrearages have been paid in full.
 - (b) Complainant agrees to withdraw his Complaint.


