

THIS LETTER IS TO OFFICIALLY INFORM YOU THAT I NO LONGER RENT AND HAVE NOT NOR WILL NOT EVER RENT AGAIN SINCE MY LAST EVICTION OF THE TENANT THOMAS JONES. THE EVICTION WAS DONE IN APRIL 2010. LT - 10 - 04 - 08 - 3809

MY HOME IS NOW A FAMILY HOME AND WILL NEVER BE USED AS A RENTAL PROPERTY AGAIN. I AM PRESENTLY ON WELFARE, LOOKING FOR WORK AND CAN NOT AFFORD TO PAY THE TRASH COLLECTION FEE OF \$300.00. I PAID THE \$150.00 LAST YEAR BECAUSE MY EVICTION WAS DURING THAT YEAR. I ADVISED THE STREETS DEPT AT THAT TIME WHEN I PAID THE \$150.00 THAT I NO LONGER WOULD BE RENTING AND DID NOT RENEW THE RENTAL LICENSE. I SUBMITTED THE EXEMPT FORM TO THE STREETS DEPT THAT I NO LONGER RENT. I ALSO SENT A COPY OF THE WELFARE PAPERS WITH ANOTHER NOTICE FROM THE STREETS DEPT FOR NON PAYMENT PENALTY. I INHERITED THIS HOME AND COULD NOT GET ALONG WITH TENANT PROBLEMS SO I NO LONGER RENT. PLEASE ADVISE IF OTHER LEGAL REQUIREMENTS MUST BE DONE TO RESOLVE THIS MATTER.

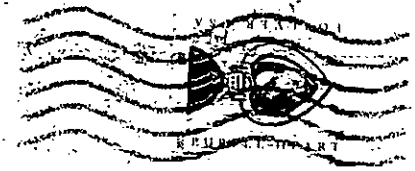
